I/We the parents/guardians of the above named candidate for a position in the Tri County Sports Authority Football Program (TCSA-FB) hereby give my/our consent and approval to participate in any and all League activities, including transportation to/from League activities if needed.

I/We will pay a \$35.00 return check fee should I/We write a bad check to the TCSA. All payments shall be settled prior to the first game.

I/We will take responsibility for maintaining and returning equipment supplied to me/my child by the TCSA in a timely manner. Should my child quit or my child's participation in League activities terminate otherwise, I will return the equipment into the coach during the next practice in good and clean condition. At the end of the season, I will return the equipment in good and clean condition to my child's coach within one week of the end of the season should I miss the scheduled turn in dates. Failure to turn equipment in good and clean condition will obligate me/us to purchase replacement equipment at the TCSA's discretion.

I/We know that participation in the TCSA may result in serious injurious and/or death and protective equipment does not prevent all injuries to players. I/We do hereby waive, release, absolve, indemnify and agree to hold harmless the TCSA, TCSA Officers and Volunteers, Corbin Recreation Department, Corbin Board of Education, Organizers, Sponsors, Coaches, City of Corbin, Participants and Persons Transporting my/our child to and from activities from any claim or liabilities arising out of injury or death to my/our child whether the result of negligence and for any other cause except to the extent and in the amount covered by accident of Liability Insurance.

I/We will observe and abide by the TCSA Code of Ethics as noted on the back of the application.

Failure to acknowledge if the participant has an allergy or physical limitation is an assertion that there are none. Parents shall communicate in writing with coaches and league officials if there are any special directions or treatments necessary regarding a participant's health while at practice or games.

**PHYSICALS:** Players participating in Junior League and Little League are required to submit a physical to the league before they can check out equipment. You may submit a copy to the league. We would advise that you keep a copy for other Fall or Spring Sports. The TCSA will not return copies to parents and will not forward for other sports.

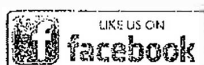

- I will ask my child to treat other players, coaches, fans and officials with respect regardless of race, sex, creed, or ability.
- I will help my child enjoy the youth sports experience by doing whatever I can, such as being a respectful fan, fulfilling my volunteer time, and continuing to have a positive mental attitude when I am asked to help.
- I will require my child's coach be trained in the responsibilities of being a sports coach.
- I have read and agree to abide by the Tri-County Sports Authority printed Parents Code of Ethics.

**Note:** It is League Policy that if a parent or fan is asked to leave the field, stands, press box, game, etc. the first time will lead to parent/fan and head coach of that parent/fan team, being suspended from the next game as well. A second time or if law enforcement is called to remove them, that person shall be banned from any further TCSA activities. Should a parent or fan be banned from TCSA activities, they may apply for reinstatement by writing the TCSA and acknowledging their conduct along with providing assurances that they will conduct themselves within the rules and regulations of the TCSA in all future activities, including other TCSA sports. This written notice must be provided at a scheduled Board meeting where at least 80% of the board members are present. Any parent or fan receiving a second ban will not be eligible for reinstatement.

**Communication:** The TCSA will do it's best to communicate with all participants. We will use our website, [www.tricountysportsauthority.com](http://www.tricountysportsauthority.com) with links to Facebook and Twitter as a means to provide updated information regarding events. Please work closely with your coach to remain up to date on practice and other scheduled events. Coaches are responsible for scheduling practice so work with them on times and dates. The league will not be able to provide any practice information. Also, in the event of rain-outs, the coaches are responsible for communicating with parents. If they haven't contacted parents, it is assumed that the event is still scheduled. Cancellation of games will be posted on the website as soon as a decision to cancel has been made. That notification will go directly to the coaches for them to contact parents.

**Participation:** The TCSA expects every participant to have an opportunity to play and has set forth rules that require playing time for each player. However, there may be circumstances where a participants playing time is limited due to safety concerns, practice attendance or practice participation. This is left up to the judgment of the team coach. Should you have a concern with your child, please contact the coach to discuss. Do not contact the league regarding someone else's child from another team.

**Sponsorship:** Football is a very expensive sport to operate. There are always needs to upgrade equipment and replace uniforms. There are also needs for helping children who can't afford to participate. If you would like to sponsor a team or contribute any amount towards operations, please contact us. We will be happy to keep your contributions anonymous or post/announce your company as a league sponsor on our website and/or at league events.

**Volunteers:** The TCSA is run by volunteers. The only personnel paid by the league are game officials. If you would be willing to volunteer, please check any item you might be willing to do.

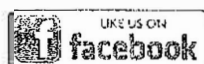
